Minutes of the Oscoda Area Schools Board of Education Regular Meeting Monday, March 12, 2018

The March 12, 2018 Regular Meeting of the Oscoda Area Schools, Iosco and Alcona Counties, Michigan, Board of Education was called to order at 7:00 p.m. on Monday, March 12, 2018 by Vice-President Ellis. The meeting was held in the Board of Education Meeting Room located in Oscoda Area High School, 3550 East River Road, Oscoda, Michigan 48750. Vice-President Ellis led the Pledge of Allegiance and Secretary Reitler read the district's Vision, Mission, and Belief statements.

Community Education Director Susan Barnhart updated the Board on the programs offered by Oscoda Community Education. She reported:

- Youth Basketball held a clinic for students in grades K-6 and 101 students participated. There was a basketball league for students in grades 3-6. There was a decline in the number of players this year.
- The Colts Football and Cheer Program for students in grades 3-6 had 46 participants last fall. There is some talk about switching to flag football this coming fall.
- Youth Wrestling Club for ages 5 through 14 had 37 athlete participate this winter.
- Country Line Dancing is held at Richardson Elementary School on Tuesdays
- Clogging is held on Mondays and Wednesdays at Cedar Lake Elementary
- Karate is held at Cedar Lake Elementary on Tuesdays and Wednesdays
- Cheer Clinic in partnership with the OHS Cheer Program is held every fall for students in grades K-6.
- Open Swim/Lap Swim is offered on Sundays and two evenings a week
- Water Exercise class is offered two days a week during the day
- Otters Swim Club for ages 5 through 18 is held October through February. Swimmers practice three days a week and have meets on the weekends. Sixty-five swimmers participated. Two swimmers qualified for the State meet and one swimmer broke the OHS pool record in two events for boys ages 8 and under.
- Blue Marlins Synchronized Swim Club is offered to people of all ages. The Club was resurrected in 2015 with 6 swimmers. The year there are 14 participants, one of which is a staff member. They are having a show in Friday, April 27th at 7:00 p.m.
- Pool parties are being offered. We have had six parties so far without much advertising
- Swim lessons are offered every year for swimmers of all ages
- The First Robotics Club started this year
- Pickleball is held in the summer at RES
- Preschool is offered three days a week during the school year at no cost to parents. We are currently in the process of renewing our license with the State
- Texas Hold 'Em tournaments are held at Vista Lanes four times a year as a way for groups to raise money
- Community Education keeps funds for Friends of Baseball and Friends of Football

OEA President Kathleen Erickson reported that the theme for March is Reading Month is Camp Read S'more. Everyone is enjoying the activities planned for the month.
